Publication of Notice in the Newspaper

Pursuant to the Ministry of Corporate Affairs (MCA) Circular No. 17/2020 dated April 13, 2020, the Notice calling the AGM has been uploaded on the website of the Company at http://selflimited.org. The public advertisement with respect to dispatch of Notice and conducting of remote e-voting was published in English in the Indian Express Newspaper on November 23, 2021 and its Malayalam translation in Deepika Newspaper on November 24, 2021.

E-voting facility

The Company has availed the e-voting facility offered by Central Depository Services (India) Limited for conducting e-voting by the shareholders of the company.

Cut-off date

The voting rights were reckoned as on November 23, 2021, being the cut-off date for the purpose of entitlement of members for remote e-voting and venue voting.

E-voting

The voting period for remote e-voting commenced on November 25, 2021 (9:00 AM) to November 28, 2021 (5:00 PM) and venue e-voting held was blocked thereafter and the votes cast under e-voting facility were then unblocked in the presence of two witnesses not being in the employment of the Company.
